2. The competent authority in CGSWMA reserves the right to cancel the tender at any time or amend/ withdraw any of the terms & conditions mentioned in the tender document without assigning any reason.

3. The service provider agencies may also apply /participate for accommodation and food/catering services separately .

#### **Scope of Work:**

- 1. CGSWMA has an annual training/ workshop expenditure of approximately 1-1.5cr.
- 2. The service provider shall be responsible for the following:
- a) <u>Catering Services</u>:

- Providing nutritious and hygienic meals as per the specified menu and dietary requirements.

- Ensuring compliance with all relevant food safety and hygiene regulations.

#### b) Accommodation Services:

- Providing comfortable and clean accommodation facilities as and when required.

- Ensuring that the accommodation facilities meet the required standards of safety, hygiene, and comfort.

- Offering competitive rates for accommodation services.

# **Eligibility Criteria:**

To be eligible for empanelment, the service provider must meet the following criteria:

- a) Valid registration and compliance with all relevant local and national regulations pertaining to food/catering and accommodation services.
- b) Demonstrated experience in providing food/catering and accommodation services to organizations of similar size and nature.
- c) Adequate infrastructure and resources to meet the requirements of our organization.
- d) A proven track record of maintaining high standards of quality, hygiene, and customer.

# **Evaluation Criteria:**

The bids will be evaluated based on the following criteria

- A. Experience and track record in providing food/catering and accommodation services .
- B. Quality and verity of menu options for catering services .
- C. Pricing competitiveness for both catering and accommodation services.
- D. Compliance with food safety and hygiene regulations .
- E. Capacity and resources to meet the organization's requirements.

# Submission Deadline:

The deadline for submitting bids is 10-03-2024. Late submission will not be considered.

# Duration:

Initially the empanelment /contract period will be for Five years (or till the wind up of project year) based on the performance of agency and can be extended with the approval of CEO CGSWMA.

#### **Process of submitting bids:**

The bids must be submitted in two separate envelopes specifying as technical and financial tender respectively.

# EMD/SD and tender processing fee

EMD/SD of 10,000/- rupees In the form of DD/challan must be submitted in favor of SLNA Chhattisgarh project fund for atleast one year of period.

The processing fee of rupees 1000/- in the form of DD in favor of SLNA Chhattisgarh project fund.

# **Technical Proposal:**

- **1.** Bidders shall submit the technical proposal in the formats at(the "Technical Proposal")
- **2.** Failure to comply with the requirements shall make the EOI liable to be rejected.
- **3.** The Technical Proposal shall not include any financial information relating to the work specified.

**<u>Bill of qualities</u>**: The rate shall be quoted (by online) against each item separately in figures.

During price Tender evaluation, the Employer will correct arithmetical errors on the following basis:

- a) If there is a discrepancy between the unit price and the total price that is obtained by multiplying the unit price and quantity, the unit prices shall prevail and the total price shall be corrected;
- b) If there is an error in a total corresponding to the addition or subtraction of sub totals, the sub total shall prevail and the total shall be corrected.
- c) The unit wise amounts will be rounded to the nearest rupee.
- d) The tendered rates of items against which no rate or price is Entered by the tendered will be taken as zero and the price of the same shall be deemed to have been covered by the rates/amount quoted in other items.
- 1. The tender document shall be written legibly and free from erasure, over writing or conversion of figure. Any correction where unavoidable shall be made by crossing out, rewriting and attestation by the tenderer.
- 2. All taxes as applicable on date including GST shall be payable by the contractor. The rate quoted by Contractor shall be excluded of GST.
- 3. Department reserves the right to take up the work departmentally or to award any work on contract in the vicinity without prejudice to the terms of contract.

#### **Opening of Bids:**

- 1. Tender proposals are to be accepted only by registered post or speed post.
- **2.** Last date and time of submission of bids: 10-03-2024 Time- 3:00 PM
- **3.** Date and time of opening of bids: 10-03-2024 Time- 4:00PM
- **4.** Firstly the technical bids will be opened and evaluated on the bases of eligibility criteria. There after financial bids of only those bidders which are declared technically qualified shall be opened publicly on the date and time

specified by CGSWMA in the presence of bidders or representative who choose to attend

**5.** All eligible tenderers shall be offered to work on the L1 item wise rates, tenderers agreeing to work at L1 rates shall be contracted for a period of 5 years (or till the wind up of project year).

# **Terms and Conditions:**

- 1. <u>Contract duration</u> : The empanelment of the food/catering and accommodation service provider will be for a period of 5 years (or till the wind up of project year), with the option for renewal based on performance.
- 2. Successful bidders shall undergo MOU /contract agreement with CGSWMA within 7 days of supply order mandatorily.
- 3. In tender proposal EMD of rupees 10,000/-(DD/Challan only in the name of SLNA Chhattisgarh project fund) shall be included in technical proposal .
- 4. Tender processing fee is non-refundable.
- 5. CGSWMA shall not pay any kind of advances.
- 6. **<u>Quality and hygiene standards</u>**: The service provider must adhere to the highest standards of quality, hygiene, food safety regulations as per the local and national laws.
- 7. <u>Menu flexibility and dietary requirements</u> : The service provider should demonstrate flexibility in accommodating special dietary requirements and preferences of the CGSWMA employees and guest.
- 8. <u>Indemnity:</u> The selected Bidder will indemnify CGSWMA Raipur for any direct loss or damage that is caused due to the Agency's fraud , willful , misconduct , gross negligence, breach of confidentiality or breach of third party intellectual property right or in the performance of the services.
- 9. <u>Payments:</u> The appropriate vendor shall raise the bill after successful completion of the work, the payment shall be made and TDS deduction shall be as per law and GST will be paid extra.
- 10. <u>Penalties</u>: If the progress of assignment is found to be non-satisfactory or

delayed at any point of time, CGSWMA Raipur reserves the right to impose penalty @3% for each default. The total amount of penalty shall not exceed 10% of total assignment fee.

- 11. The sole jurisdiction of all disputes will be Raipur C.G.
- 12.In case of any dispute, the final decision will be taken by CEO CGSWMA which shall be acceptable to food/catering and accommodation service provider.
- 13.CEO CGSWMA can cancel the tender at any point of time if he finds necessary without giving any reason.
- 14.Termination clause : CEO CGSWMA reserve the right to terminate the empanelment agreement. If there is any breach / unsatisfactory performance or any other reason .
- 15.CEO CGSWMA may ask for price negotiation to vendor if he thinks it necessary.
